Purpose

We, the undersigned affected Knollwood Ave residents/property owners, support County consideration of a timed school-hour No Parking restriction for the affected segment of Knollwood Ave near Stage Coach Ln.

The request is based on recurring school-hour parking conditions that reduce effective roadway width, limit sight distance and visibility, create turning conflicts near the Stage Coach Ln entrance, and may affect emergency, residential, mail, delivery, trash, and other service access.

Requested County / TAC Consideration

- Establish a timed No Parking restriction during school days / Monday-Friday from 8:00 AM to 4:00 PM.
- Apply the restriction on the East side of Knollwood Ave, beginning at the Stage Coach Ln entrance and extending Northerly approximately 375 feet.
- Allow County staff to determine final sign placement, sign wording, and any appropriate engineering adjustments under the applicable County process.
- Process the request through the appropriate County review path, including Traffic Advisory Committee review if required.

Affected Area / Map Note

This petition should be submitted with a map or photo exhibit identifying the requested segment. The affected area should include the properties along both sides of the County-maintained road where the proposed restriction would apply or directly affect, subject to County review and comment.
